THE TREE PLANTING (VILLAGE AREAS) LAW.  
CAP. 175 AND LAW 56 OF 1955.

## ORDER UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Kato Dhrys in the District of Larnaca on the 14th October, 1956, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Kato Dhrys ;

And whereas the Mukhtar of the said village of Kato Dhrys has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law :

Now, therefore, I, the Commissioner of the District of Larnaca, having approved the said report do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the village of Kato Dhrys.

## SCHEDULE.

The area lying within the following boundaries that is to say :—

The boundary commences at the most southern point of plot No. 120 of the Government Survey Plan No. XLIX.27, locality "Peramosphilia", which point is on the village boundary between the villages of Kato Dhrys and Pano Lefkara and proceeds in an easterly direction along the said village boundary to the most southern point of plot No. 217 of the Government Survey Plan No. XLIX.28 ; thence in a northerly and westerly direction along the boundaries of and including the said plots Nos. 213, 210, 209, 206, 188, 187, 185, 178, 175, 165, 163, 162, and 146 of the said plan, to the most western point of the last mentioned plot, which point is on a footpath ; thence southwards along the said footpath to the most eastern point of plot No. 143 of the said plan ; thence north-westwards along the boundary of the said plot to the most northern point of the said plot (but excluding the last mentioned plot) ; thence in a southerly direction along the boundaries of and including plots Nos. 136, 137, 138, 128, 117, 118, 121, 122, 515, 338, 350, 352, 360, 353, 353/2, 428, 429, and 432 of the said plan, plots Nos. 13, 433 (part), 33, 32, 29, 31, 42, 44, 45, 139 (part), 138, 132, 94, 131, 126, 130, 127, 121, 104, 105 and 106 of the Government Survey Plan No. XLIX.36, to the most eastern point of the last mentioned plot, locality "Philippiaes", which point is on the junction of Vavla River with a stream ; thence in a westerly direction along the left bank of the said river to the most western point of plot No. 671 of the Government Survey Plan No. XLIX.35, which point is on the junction of the said river with the road leading from Kato Dhrys village to Vavla village ; thence northwards along the said road to the most northern point of plot No. 672 of the said plan, which point is on a stream ; thence northwards along the said stream to the south-eastern corner of plot No. 420 of the Government Survey Plan No. XLIX.27 ; thence in a north-westerly direction along the boundaries of and including the said plot, plots Nos. 425, 426, 432, 431, 427, 428, 430, 434, 435, 449, 450, 451, 452, 447, 446, 473, 479, 477, 495, 497, 505, 504 and 502 of the said plan, to the south-western corner of the last mentioned plot, which corner is on a stream ; thence north-westwards along the said stream to the point of commencement. All which said area is 2,236 donums or thereabouts, as shown edged in red on the Government Survey Plan Serial No. 1672.
