THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 1) 1957.

ORDER MADE UNDER REGULATION 39A.

Whereas I, the Commissioner of the District of Nicosia, am satisfied that the structure described in the Schedule hereto (hereinafter referred to as "the structure") is a structure which is being used by terrorists, in exercise of the powers vested in me by Regulation 39A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 1) 1957, with the approval of the Governor, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Forfeiture and Demolition) (Nicosia District No. 2) Order, 1957.
2. It is hereby directed that the structure be forfeited and demolished.

SCHEDULE.

Wall bounding the cemetery, etc., on Plot 350 Akaki, belonging to Church of Panayia Chryseleousa situate west of Akaki village on the main Akaki-Peristerona road seventy yards from the river bridge.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 17) 1956.

ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the premises described in the Schedule hereto (hereinafter referred to as "the premises") and to authorize its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 17) 1956, which I have been authorized to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Nicosia and Kyrenia, have taken possession of the premises with effect from 27th November, 1956, and in connection with the taking, possession and making use of the premises, I hereby direct and order as follows :—

- (1) The use of the premises for the requirements of Her Majesty's Forces is hereby authorized.
- (2) The persons using the premises in pursuance of this Order are hereby authorized to do, in relation to the premises, anything which any person having an interest in the premises would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the premises, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the premises or otherwise, is hereby prohibited.

## SCHEDULE.

The privately owned premises with all appurtenances, consisting of houses, gardens and trees, situated at Lapithos village, Kyrenia District, Sheet/Plan XI.23.vil.plot No. 95 and Sheet/Plan XI.23.vil.plot No. 97/2=404 and Sheet/Plan XI.23.vil.plot No. 97/3 more particularly defined as the area coloured red on the plan deposited in the Office of the Commissioner at Nicosia.

## ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorise its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations 1955 to (No. 10) 1956, which I have been authorised to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Limassol, hereby take possession of the land and, in connection with the taking possession and making use of the land, I hereby direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorised.
- (2) The persons using the land in pursuance of this Order are hereby authorised to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

## SCHEDULE.

All that area of privately owned land at Ayia Phyla Village being part of Plot No. 344 on the Government Survey SH/PL LIV.41 and more particularly defined as the area coloured red on the Plan signed by the Commissioner of Limassol and dated 1st August, 1956, a copy of which is available for inspection at the Office of the Commissioner, Limassol.
