

**No. 233.****THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 1) 1957.****ORDER MADE UNDER REGULATION 39 (1).**

I, the Assistant Commissioner of Kyrenia, in exercise of the powers vested in me by paragraph 1 of Regulation 39 of the Emergency Powers (Public Safety and Order) Regulations, 1955, do hereby order as follows:—

2. This Order may be cited as the Closing of Premises (Kyrenia District No. 4) Order, 1957.

3. That in the interest of public order and safety, the premises described in the Schedule hereto shall be closed with effect from the 8th February, 1957, and remain closed until further notice.

**SCHEDULE.**

The Shop property standing on Plot Nos. 61/1, 62/4 and 63/2 of Government Survey Sheet Plan XII/20 T., which is situated on the corner of Catsellis Street and Hellas Street, Kyrenia Town.

**No. 234. THE LAND ACQUISITION LAW.**

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

**NOTICE UNDER SECTION 6.**

With reference to the Notification No. 107 published in Supplement No. 3 to the *Gazette* of the 16th February, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

All those areas of privately owned lands, with everything standing thereon, situated at Eylenja and Strovolos villages, comprising 4 donums, 1 evlek or thereabouts and forming parts of plots Nos. 173, 502, 501, 174, 177, 376, 377, 180, 181 and 185 of Block B, Eylenja village and part of plot No. 364 of Block N, Strovolos village, more particularly defined as the areas coloured red and green on the plan signed by the Director of Public Works and dated the 1st February, 1957.

*Note* :—The area coloured green on the said plan is to form road protecting strip and the intention is not to cede it to the public road.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said lands.

4. The plan referred to above is available for inspection at my office.
