THE EMERGENCY POWERS ORDERS IN COUNCIL, 1939 AND 1956.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 6.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1956, I, the Governor, do hereby make the following Regulations:—

1. These Regulations may be cited as the Emergency Powers (Public Short title. Safety and Order) (Amendment No. 2) Regulations, 1957, and shall be read as one with the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 1) 1957 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 2) 1957.

2. Regulation 52 of the principal Regulations (as set out in Regulation 2 Amendment of the Emergency Powers (Public Safety and Order) (Amendment No. 16) Regulations, 1956) is hereby amended by the substitution of the following sub-paragraph for sub-paragraph (d) thereof:-

"(d) carry, or have in his possession or under his control, or manufacture or assist in manufacturing, any explosive article, substance or liquid, other than ammunition or a bomb or grenade, with intention to cause death or injury to any person or damage to any property,".

- 3. Regulation 53A of the principal Regulations (as set out in Regulation 4 of the Emergency Powers (Public Safety and Order) (Amendment No. 16) Regulations, 1956) is hereby amended as follows:—
 - (a) by the substitution of the following paragraph for paragraph (2) thereof:—
 - "(2) Any person who, without lawful excuse, consorts with or is found in the company of another person who is carrying or has in his possession or under his control any firearm, ammunition, bomb or grenade in contravention of the provisions of sub-paragraph (c) of regulation 52, in circumstances which raise a reasonable presumption that he knew that such other person was carrying or had in his possession or under his control any such firearm, ammunition, bomb or grenade in contravention of the provisions of the said sub-paragraph (c), shall be guilty of an offence and shall be liable on conviction to imprisonment for life or for such lesser term as the Court may see fit to impose.";
 - (b) by the insertion therein, immediately after paragraph (2) thereof, of the following new paragraph:—
 - "(2A) Any person who, without lawful excuse, consorts with or is found in the company of another person who is carrying or has in his possession or under his control any incendiary article, substance or liquid or any explosive article, substance or liquid, other than ammunition or a bomb or grenade, in contravention of the provisions of sub-paragraph (a) or sub-paragraph (b), as the case may be, of Regulation 53, in circumstances which raise a reasonable presumption that he knew that such other person was carrying or had in his possession or under his control such incendiary article, substance or liquid, or such explosive article, substance or liquid, in contravention of the provisions of the said sub-paragraph (a) or the said sub-paragraph (b), as the case may be, shall be guilty of an offence, and shall be liable on conviction to imprisonment for a term not exceeding ten years."
