

**No. 250. THE CONTAGIOUS DISEASES (ANIMALS) LAW.  
CAP. 65.**

**ORDER UNDER SECTION 4 (1) (h).**

In exercise of the powers vested in him by section 4 (1) (h) of the Contagious Diseases (Animals) Law, His Excellency the Governor has been pleased to make the following Order :—

2. This Order may be cited as the Holding of Animal Markets and Fairs (Prohibition) Order, 1957.

3. For the purposes of this Order " animal " means bulls, cows, oxen, heifers, calves, pigs, sheep and goats.

4. The holding of markets or fairs anywhere in the Colony for the sale of any animal is hereby prohibited until further notice.

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.**

**ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.**

Whereas by Order dated the 16th September, 1955, and published in Supplement No. 3 to the *Gazette* of the 17th September, 1955, under Notification No. 546 (as amended by Notification No. 92 in Supplement No. 3 to the *Gazette* of the 9th February, 1956) (hereinafter referred to as "the Order") His Excellency the Governor had authorised the use for military purposes of the land and property set out in the Second Schedule to the Order situated in the village of Kato Polemidhia and in Chiftlikler Quarter, Limassol town (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 219 and 968 published in Supplement No. 3 to the *Gazettes* of the 22nd March, 1956, and the 11th October, 1956, respectively, the Order was extended for further periods of six months up to the 15th March, 1957 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1956), His Excellency the Governor has been pleased to order and hereby orders that the aforesaid authorization for using the land for military purposes subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 16th March, 1957, and the Order is so extended accordingly.
