THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 1) 1957.

ORDER MADE UNDER REGULATION 60A.

Whereas I consider it expedient in the interests of public safety to make a clearance order in respect of the land described in the Schedule hereto :

Now, therefore, I, the Commissioner of Famagusta, in exercise of the powers vested in me by Regulation 60A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 1) 1957, do hereby order as follows:—

I. This Order may be cited as the Emergency Powers (Clearance) (Famagusta District No. 2) Order, 1957.

2. The owners and occupiers of the land described in the Schedule hereto (hereinafter referred to as "the land"), and the agents of such owners and occupiers, are hereby directed—

- (a) to cut and clear away from the land all herbage, bush and undergrowth;
- (b) to cut flush with the trunk and clear away the branches of all cypress trees standing on the land to a height of 12 feet from ground level and of all fruit trees to a height of six feet from ground level;
- (c) to cut and clear away such eucalyptus trees as may be indicated by the Assistant Chief Constable, Famagusta;
- (d) to prevent any herbage, bush or undergrowth on the land from growing higher than one foot and to maintain the land in a clean condition to the satisfaction of the Assistant Chief Constable, Famagusta.

SCHEDULE.

The area of land abutting on or lying within a distance of fifty yards from the following section of public road :----

From and including culvert No. 14/1 in the Village of Akhna southwestwards to the boundary between Famagusta and Larnaca Districts on the Famagusta-Larnaca Road.

No. 256. THE TREE PLANTING (VILLAGE AREAS) LAW. CAP. 175 and Law 56 of 1955.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Nata in the District of Paphos on the 9th December, 1956, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Nata;

And whereas the Assistant District Inspector appointed by me under section 14 of the said Law, has forwarded to me a report signed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law:

Now, therefore, I, the Commissioner of the District of Paphos, having approved the said report, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Nata.

SCHEDULE.

The area consists of Parts A and B as follows :---

Part A.

All that area contained within the boundaries of plot No. 518, plan No. LI/8, locality "Karoulloudhi", plot No. 106, plan No. LII/I, plots Nos. 167, 168, 166, 169, 170, 171, 172, 173, locality "Kara Hassani", plots Nos. 174, 175, 176, 177 and 178, plan No. LI/16, locality "Lizato".

Part B.
