THE BURIALS LAW.
CAP. 53 AND LAW 33 OF 1955.

ORDER UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Burials Law, and delegated to me by Notification No. 172 published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I, the Commissioner of the Districts of Nicosia and Kyrenia, do hereby order that a new burial ground shall be provided, under the provisions of the said Law, for use by the Christian-Orthodox community of the village of Kaliana, in the District of Nicosia.

No. 336. THE TREE PLANTING (VILLAGE AREAS) LAW.
CAP. 175 AND LAW 56 OF 1955.

ORDER UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Pano Lefkara in the District of Larnaca on the 29th January, 1956, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said Village of Pano Lefkara;

And whereas the Mukhtar of the said village of Pano Lefkara has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law:

Now, therefore, I, the Commissioner of the District of Larnaca, having approved the said report do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the village of Pano Lefkara.

SCHEDULE.

Area "A"

The area lying within the following boundaries, that is to say:—

The boundary commences at the most northern point of plot No. 444 of the Government Survey Plan No. XLIX.4, locality "Lephtouathia", which point is on the right bank of the river Syrgatis and proceeds south-eastwards along the said bank of the said river to the north-eastern corner of plot No. 222 of the Government Survey Plan No. XLIX.13; thence south-westwards and north-westwards along the boundaries of and including the said plot, plots Nos. 227, 336 (part), 334, 323, 324, 320, 234, 294, 296, 298, 299, 295, 288, 291, 289 and 290 of the said plan, plots Nos. 798, 797, 795, 814, 794, 721, 725, 731, 695, 694, 690, 687, 686, 685, 670, 672, 658, 657, 673, 674, 656, 675, 677, 654, 566, 554, 580, 581, 583, 578, 577, 576, 616, 617 and 615 of the Government Survey Plan No. XLIX.12, plots Nos. 446 and 444 of the Government Survey Plan No. XLIX.4, to the point of commencement.

Area " C ".

The area lying within the following boundaries, that is to say :—

The boundary commences at the most western point of plot No. 654/1 of the Government Survey Plan No. XLIX.28, locality " Anemomylos " which point is on the boundary between the villages of Pano Lefkara and Kato Drys and proceeds in a westerly direction along the boundaries of and including the said plot, plots Nos. 655/1, 653, 655, 656, 657, 659, 659/1, 660/1, 660, 665/1, 665, 690, 686, 687, 716, 722, 724, 725, 728, 727, 731, 732, 735 and 733 of the said plan, to the north-western corner of the last mentioned plot, which corner is on the boundary between the villages of Pano Lefkara and Kato Lefkara ; thence south-eastwards along the said boundary to the most eastern point of plot No. 588 of the Government Survey Plan No. XLIX.29 ; thence in a southerly direction along the boundaries of and including the said plot, plots Nos. 596, 595, 799, 797, 802 and 801 of the said plan, plots Nos. 783, 784, 789, 787, 797, 798, 799, and 801 of the Government Survey Plan No. XLIX.28, locality " Kaspari " to the most southern point of the last mentioned plot, which point is on

the boundary between the villages of Pano Lefkara and Kato Drys ; thence north-westwards along the said village boundary to the point of commencement.

The boundaries of the said areas " A ", " B " and " C ", are more particularly delineated in red on the Government Survey Plan Serial No. 1677 and include an area of 4,398 donums or thereabouts.

No. 337. THE LAND ACQUISITION LAW.

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTICE UNDER SECTION 6.

With reference to Notification No. 107 published in Supplement No. 3 to the *Gazette* of the 16th February, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

All those areas of privately owned lands, with everything standing thereon, comprising 48 donums or thereabouts, forming parts of plots Nos. 76, 75, 74, 101, 70, 137, 138, 139, 140, 159, 162, 191, 161, 396 and the whole of plot No. 395, parts of plots Nos. 193, 220, 201, 219, 202, 215, 216 and 266 of Block D, Nisou village, part of plot No. 343 of Block C of the said village, parts of plots Nos. 375, 408, 409 and 378 of Block D of the said village, parts of plots Nos. 86, 446, 444, 85, 449, 107, 108, 106, 110 and 450 of Block E of the said village, parts of plots Nos. 50, 179 and the whole of plot No. 180 of Block A of the said village, parts of plots Nos. 172, 175, 494, 291 and 292 of Block E of the said village and parts of plots Nos. 406, 19, 21, 23, 45 and the whole of plot No. 44, parts of plots Nos. 100, 101, 418, 111 and the whole of plot No. 149, parts of plots Nos. 457, 175, 176, 179 and 180 of Block B, Perakhorio village, more particularly defined as the areas coloured red and green on the plans signed by the Director of Public Works and dated the 8th March, 1957.

Note.—The areas coloured green on the said plans are to form road protecting strips and the intention is not to cede them to the public road.

2. Any person claiming to have any right or interest in the said lands, who objects to the acquisition, is required within ten days from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said lands.

4. Plans showing the lands described above are available for inspection at my office.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.
