THE POST OFFICE LAW.
CAP. 281 AND LAW 44 OF 1953.

ORDER IN COUNCIL No. 2922
MADE UNDER SECTION 7.

In exercise of the powers vested in him by section 7 of the Post Office Law, **Cap. 281** His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

1. This Order may be cited as the Post Office (Parcels Post Rates of Postage) Order, 1957.

2. The respective rates of postage set forth in the Schedule hereto shall be charged by the Postmaster-General in respect of parcels posted in the Colony for conveyance to places therein mentioned.

3. This Order shall come into operation on the 8th day of April, 1957, and thereupon the Post Office (Parcels Post Rates of Postage) Order, 1956, shall be **Gazettes :

Authority to the Improvement Board of Karavostasi to contract a loan.

In exercise of the powers vested in me by section 22 (a) (i) of the Villages (Administration and Improvement) Laws, 1950 and 1953, I, the Acting Administrative Secretary, do hereby order as follows :—

1. The Improvement Board of Karavostasi (hereinafter referred to as "the Board") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lenders") a sum not exceeding nine hundred and
