LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1956, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Limassol District No. 9) Order, 1957.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Limassol or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 20th day of March, 1957.

FIRST SCHEDULE.

Within the Chiftlikoudhia quarter in Limassol town, from the western mouth of Garyllis river, north-west along the river for a distance of half a mile; south-west to the Municipal boundary; along the boundary to the sea, including also the village of Zakaki.

SECOND SCHEDULE.

From 04.00 hours until 18.00 hours on the 20th March, 1957.
