In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, Cap. 142, the Village Health Commission of Astromeritis hereby make the following rules :—

1. These rules may be cited as the Village Health (Astromeritis) (Amendment No. 2) Rules, 1957, and shall be read as one with the Village Health (Astromeritis) Rules, 1938 to 1957 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Astromeritis) Rules, 1938 to (No. 2) 1957.

2. The principal Rules are hereby amended by the insertion immediately after rule 44 of the following rule :—

"Rule 45. The shops, stalls, places and space situated in the meat market may be let on hire by the Village Health Commission for such period and on such terms and conditions as the Village Health Commission may from time to time determine."
