**THE CURFEWS LAWS, 1955.**  
LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District No. 18) Order, 1957.

2. No person within the area prescribed in the Schedule hereto shall be out of doors between the hours of 18.00 and 05.00 daily until further notice except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any person born on or before 1st January, 1930, members of Her Majesty's Forces, or the Cyprus Police Force.

This Order is in addition to and not in derogation of Curfew Order (Nicosia District No. 32), 1956, as amended.

SCHEDULE.

The municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Larnaca District No. 3) Order, 1957.

2. No person within the area specified in the First Schedule hereto, and born on or after 1st January, 1930, will be out of doors between the hours prescribed in the Second Schedule hereto, except under the authority of a written permit granted by the Commissioner of Larnaca or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of Her Majesty's Forces, or of the Cyprus Police Force.

This Order shall come into force at 18.00 hours on the 29th day of March, 1957.

FIRST SCHEDULE.

Within the municipal boundaries of Larnaca.

SECOND SCHEDULE.

Between 18.00 hours on 29th March, until 05.00 on 30th March, 1957.
