THE LAND ACQUISITION LAW. CAP. 233 and Laws 26 of 1952 and 22 of 1956.

Notice under Section 6.

With reference to Notification No. 124 published in Supplement No. 3 to the *Gazette* of the 23rd February, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :---

All those areas of privately owned lands, with everything standing thereon, situated at Xylotymbou village, comprising 40 donums and 2 evleks or thereabouts, forming parts of plots Nos. 80/1, 80/2, 80, 77, 78/1, 78/2, 79/1, 79/2, 81/1, 81/2, 82/1, 82/2, 83/1, 83/2, 89/2, 89/3, 90/1, 90/2, 91/1, 95, 94/1, 94/2, 92/1, the whole of plots Nos. 93/3 and 92/3, parts of plots Nos. 92/2, 93/1, 93/2, 55/1/1, 55/1/2, 169/2/2, 169/1, 168/1, 168/2, 167/1, the whole of plot No. 167/2, parts of plots Nos. 175/1, 175/3, 175/2, 174, 206/1, 208, 223, 224, 207, 201/2, 201/1, 226, 227, 234, 235, 236, 233, 268/1, 267, 255, 264, 262 and 261 of the Government Survey Plan No. XXXII.61, parts of plots Nos. 131, 132, 130, 134/5, 135, 143, 142/1, 137, 138/1 and 138/2 of the Government Survey Plan No. XXXII.60 and parts of plots Nos. 92, 86, 82, 80, 75, 79, 76/3, 77, 72, 69/1, 210/1, 210/2, 210/3, 210/4, 208/5 and 208/4 of the Government Survey Plan No. XLI.4, more particularly defined as the areas coloured red and green on the plan signed by the Director of Public Works and dated the 26th March, 1957.

Note :—The areas coloured green on the said plan are to form road protecting strips and the intention is not to cede them to the public road.

2. Any person claiming to have any right or interest in the said lands, who objects to the acquisition, is required within ten days from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.
