# THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 3) 1957.

#### ORDER MADE UNDER REGULATION 35A.

Whereas it has come to my notice that illegal slogans have been painted on the main road from Boghaz to Rizokarpaso between the sixty-first and sixty-fourth milestones, now, therefore, I, the Commissioner of Famagusta, in exercise of the powers conferred upon me by Regulation 35A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, do hereby order as follows :--

1. This Order may be cited as the Removal of Illegal Slogans from Roads (Famagusta District No. 1) Order, 1957.

2. The use of the Boghaz to Rizokarpaso main road between the sixty-first and sixty-fourth milestones is prohibited.

3. This Order shall come into force at 13.00 hours on Saturday 1st June, 1957, and shall remain in force until further notice.

Notice (No. 14) UNDER CLAUSE 3 OF THE FIRST SCHEDULE.

The import into the Colony by any importer registered under the provisions of the Defence (Registration of Importers) Order, 1956, of the goods shown in the List hereunder is hereby permitted without a written licence under regulation 3 (1) (a) of the above named Regulations, subject to the following terms and conditions :—

(a) That, unless the contrary is stated in the List hereunder, such goods shall originate in any of the following countries and shall be imported from such country of origin, that is to say the

United Kingdom, any British Colony, Australia, New Zealand, Union of South Africa, India, Pakistan, Ceylon, Irish Republic, Austria, Belgium (including overseas dependent territories), Denmark, France (including overseas dependent territories), Greece, German Federal Republic, Italy, Luxemburg, Nether-lands (including overseas dependent territories), Norway, Portugal (including overseas dependent territories), Spain, Sweden, Switzerland, Turkey, Egypt, Eritrea, Ethiopia, Iran, Iraq, Israel, Jordan, Lebanon, Libya, Sudan, Syria.

- (b) That payment for such goods shall be made either-
  - (i) in sterling; or
  - (ii) in the case of goods imported from a country whose Gazette: currency is specified under the Exchange Control (Speci- Suppl. No 3: fied Currency) Order, 1957, or any Order amending or 14.2.1957. replacing the same, in the currency of such country.
