THE EXCHANGE CONTROL LAWS, 1952 AND 1954.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTIONS 7, 25 AND 33.

In exercise of the powers vested in me by sections 7, 25 and 33 of the Exchange Control Laws, 1952 and 1954, I, the Financial Secretary, hereby order as follows:-

1. This Order may be cited as the Exchange Control (Payments) (Amendment) Order, 1957, and shall be read as one with the Exchange Control (Payments) Orders, 1954 to 1956 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Exchange Control (Payments) Orders, 1954 to 1957.

2. The principal Order is hereby amended as follows:-

(i) by substituting for clause 4 thereof (as set out in clause 2 of the Exchange Control (Payments) (Amendment) Order, 1956) the

following clause :-

"4. The exemptions from the provisions of section 7 of the Gazette: Suppl. No. 3: Law, granted by this Order shall not apply in relation to 16.8.1956. the transfer of the whole or any part of an amount, or a payment made in cash from moneys, standing to the credit of-

(a) an Egyptian Account, or

(b) a No. 2 Account of a bank in the Egyptian Monetary Area";

(ii) by inserting after paragraph (a) of clause 6 thereof the following

paragraph:

"(b) 'Egyptian Account' means an account of a person resident in the Egyptian Monetary Area which is for the time being recognized by the Financial Secretary as an Egyptian Account for the purposes of this Order;

'No. 2 Account of a bank in the Egyptian Monetary Area' means an account which is for the time being recognized by the Financial Secretary as a No. 2 Account of a bank in the Egyptian Monetary Area for the purposes of this Order;";

(iii) by substituting for paragraph (e) of clause 6 thereof (as set out in Gazette: clause 2 of the Exchange Control (Payments) (Amendment) Order, Suppl. No. 3: 1956) the following paragraph:

"(e) 'Transferable Account territory' means any territory which is outside the scheduled territories and is not a territory specified in the First Schedule to this Order;";

(iv) by deleting item 2A from the Third Schedule thereto (as set out Gazette: in clause 2 of the Exchange Control (Payments) (Amendment) Suppl. No. 3: 16.8.1956. Order, 1956).

THE CURFEWS LAWS, 1955. LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the Gazette of the 19th July, 1956, I do hereby order as follows :-

- 1. This Order may be cited as the Curfews (Limassol District No. 10) Order, 1957.
- 2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Limassol or the Assistant Chief Constable in charge of

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 2nd day of June, 1957.

Within the village boundaries of Prastio (Evdhimou).

SECOND SCHEDULE.

From 17.00 hours on Sunday the 2nd June, 1957, until 17.00 hours on Friday the 7th June, 1957.
