ORDER IN COUNCIL No. 2941

MADE UNDER SECTION 7.

In exercise of the powers vested in him by section 7 of the Post Office Law, His Cap. 281. Excellency the Governor, with the advice of the Executive Council, has been pleased 44 of 1953 to order as follows:-

- 1. This Order may be cited as the Post Office (Parcels Post Rates of Postage) Gazette: (Amendment) Order, 1957, and shall be read as one with the Post Office (Parcels Supplement Post Rates of Postage) Order, 1957 (hereinafter referred to as "the principal Order") No. 3: and the principal Order and this Order may together be cited as the Post Office (Parcels 4.4.1957. Post Rates of Postage) Orders, 1957.
- 2. The Schedule to the principal Order is hereby amended by the deletion therefrom of the entries relating to the countries shown in the Schedule hereto and the substitution therefor of the entries relating to the same countries set out in the Schedule hereto.
 - 3. This Order shall come into operation on the 1st day of July, 1957.
