In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, and the powers vested in me by Regulation 69, I hereby give notice that without prejudice to anything done or left undone thereunder, the Order made by me on the 25th May, 1956, and published under Notification No. 521 in Supplement No. 3 to the *Gazette* dated 14th June, 1956, and amended by Notification No. 164 in Supplement No. 3 to the *Gazette* dated 14th February, 1957, is further amended as from the date hereof as follows :—

- (i) by the deletion of the words "and fence" appearing in paragraph 2 of the Schedule ;
- (ii) by the deletion of the words "fences and" appearing in paragraph 3 of the Schedule ;
- (iii) by the deletion of paragraph 4 of the Schedule.
