In exercise of the powers vested in him by section 124 (1) of the Municipal Corporations Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. The Order in Council No. 2745 made under section 124 (1) of the Municipal Corporations Law and published under Notification 197 in Supplement No. 3 to the *Gazette* of the 31st March, 1955, is hereby amended by the substitution for sub-paragraph (c) of paragraph 1 of the following sub-paragraph :

“(c) the sum borrowed shall be utilized by the Municipal Corporation for the improvement of streets within the municipal limits, erection of public latrines and acquisition of a suitable and adequate site for the erection thereon of a Municipal Day Nursery.”

**No. 658.****THE PUBLIC HEALTH (VILLAGES) LAW.**

CAP. 142.

ORDER IN COUNCIL No. 2943

MADE UNDER SECTION 10.

*Authority to the Village Health Commission of Vatili (Famagusta District) to contract a loan.*

In exercise of the powers vested in him by section 10 of the Public Health (Villages) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. The Village Health Commission of Vatili (Famagusta District) (hereinafter referred to as “the Village Health Commission”) shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as “the Lender”) the sum of three thousand six hundred and eighty pounds (£3,680) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions :—

- (a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in ten equal annual instalments (comprising sinking fund and interest);
- (b) the Village Health Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate;
- (c) the sum borrowed shall be utilized by the Village Health Commission for the reconditioning of the village streets.

2. For the purpose of securing the repayment of the sum due under the loan the Village Health Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the fees, charges and rates now payable or hereafter to become payable to the Village Health Commission under the provisions of the Public Health (Villages) Law.

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 79B (b).

Whereas a trade dispute exists between the employees of the Cyprus Inland Telecommunications Authority and the said Authority ;

And whereas all works and services connected with telephones, telegraphs, submarine cables and wireless are essential works for the purposes of the Essential Works Order, 1943 ;

And whereas a strike is threatened by the said employees :

Now, therefore, in exercise of the powers vested in him by paragraph (b) of the Defence Regulation 79B of the Defence Regulations (as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force under the provisions of the Supplies and Services (Continuance) Order, 1956) His Excellency the Governor has been pleased to make the following Order :

1. This Order may be cited as the Prevention of Strike (Telecommunications) Order, 1957.

2. Pending the determination of the trade dispute between the employees of the C.I.T.A. and the said Authority by a Tribunal to be established for that purpose, all employees of the Cyprus Inland Telecommunications Authority and all persons employed in works or services connected with telephones, telegraphs, submarine cables and wireless are hereby prohibited from going on strike.

3. This Order shall be in force for a period of three months from the date hereof and shall then expire.
