**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 79B.

In exercise of the powers vested in him by paragraph (a) of the Defence Regulation 79B of the Defence Regulations (as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946), which continues in force under the provisions of the Supplies and Services (Continuance) Order, 1956, His Excellency the Governor has been pleased to make the following Order :—

1. This Order may be cited as the Trade Dispute (Cyprus Inland Telecommunications Authority) (Tribunal) Order, 1957.

2. In this Order, unless the context otherwise requires—

“ trade dispute ” means the existing trade dispute between the Cyprus Inland Telecommunications Authority and its servants or employees in connection with the terms and conditions of the employment and the amount of wages payable ;

“ tribunal ” means the tribunal established under this Order.

3. It is hereby established a tribunal for the settlement of the trade dispute consisting of :—

- (a) Dr. Wilber William Weir, O.B.E., *Chairman*.  
 (b) Shukri Veysi  
 (c) Andreas Christou } *Members*.

4.—(1) The tribunal shall inquire into the trade dispute and make its award without delay :

Provided that in case of disagreement the majority's award shall be the award of the tribunal :

Provided further that if none of the members agree, the opinion of the Chairman shall prevail.

(2) The award shall be submitted to the Governor who shall as soon as possible cause the same to be published in the *Gazette* and thereupon such award shall be binding on all parties.

5.—(1) Save as is otherwise provided in this clause, the tribunal shall regulate its own procedure and shall not be bound by the rules of evidence in civil or criminal cases.

(2) The sittings of the tribunal shall be private and no representatives of the press shall be allowed to attend the proceedings.

(3) The tribunal shall permit any interested person to appear in any proceedings before it through an advocate.
