THE CONSULAR CONVENTIONS LAW, 1952.

ORDER IN COUNCIL No. 2948

MADE UNDER SECTION 8 (1).

Whereas by section 8 (1) of the Consular Conventions Law, 1952 (hereinafter referred to as "the Law") it is enacted that the Governor may, by Order-in-Council, direct that sections 2, 4, 6 or 7 of the Law shall apply by Order-in-Council, direct that sections 2, 7, 0 of 7 of the Law shall apply to any foreign state specified in the Order, being a state with which a consular convention providing for matters for which provision is made by those sections has been concluded by Her Majesty : And whereas a consular convention (hereinafter referred to as "the

Convention") between Her Majesty Queen Elizabeth the Second in respect

of the United Kingdom of Great Britain and Northern Ireland and the President of the Federal Republic of Germany was signed at Bonn on the 30th day of July, 1956, which provides for matters for which provision is made in the said sections 2, 4, 6 and 7, and Article 44 of which provides that the Convention shall be subject to ratification and shall not enter into force until the thirtieth day after the date of the exchange of instruments of ratification :

And whereas by Exchanges of Notes between Her Majesty's Ambassador at Bonn and the Federal German Minister for Foreign Affairs, on the 30th day of July, 1956, it was agreed that, notwithstanding the terms of the said Article 44 of the Convention, Articles 13, 14, 15 and 16 of the Convention relating to Financial Privileges should be brought into operation forthwith, subject to the limitations set out in the aforesaid Exchanges of Notes and in accordance with the terms thereof :

Now, therefore, in exercise of the powers vested in him by section 8 (1) of the Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :--

1. This Order may be cited as the Consular Conventions (Federal Republic of Germany) (Financial Privileges) Order, 1957.

2. Section 6 of the Law shall apply to the Federal Republic of Germany.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 18th January, 1956, and published in Supplement No. 3 to the *Gazette* of the 26th January, 1956, under Notifica-tion No. 58 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Liveras (hereinafter referred to as "the land") subject to the restrictions and conditions therein laid down for a period of six months;

And whereas by virtue of Notifications Nos. 641 and 1284 published in Supplement No. 3 to the Gazette of the 12th July, 1956, and 28th December, 1956 respectively, the Order was extended for further periods of six months up to the 17th July, 1957;

And whereas the Governor's Deputy is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Gazette: Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1956), the Governor's Deputy has been pleased to order and hereby orders that the aforesaid authorisation for using the land for military purposes subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 18th July, 1957, and the Order is so extended accordingly.
