

**No. 725.** THE LAND ACQUISITION LAW.  
CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTICE UNDER SECTION 6.

With reference to Notification No. 538 published in Supplement No. 3 to the *Gazette* of the 23rd May, 1957, notice is hereby given that the following land is required for the undertaking of public utility mentioned therein.

All that area of privately owned land, with everything standing thereon, situated at Ayios Loukas Quarter, Famagusta Town, comprising 50 donums or thereabouts, forming part of plot No. 88 of Block C, more particularly defined as the area coloured red on the plan signed by the Director of Education and dated the 11th July, 1957.

2. Any person claiming to have any right or interest in the said land who objects to the acquisition is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said land.

4. A plan showing the land described above is available for inspection at my office.

**No. 726.** THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 3) 1957.

ORDER MADE UNDER REGULATION 44.

Whereas by Order dated 10th July, 1956, published in Supplement No. 3 to the *Gazette* of the 10th July, 1956, under Notification No. 686, (hereinafter referred to as "the Order"), I authorised the use by the Security Forces of the properties set out in the Second Schedule to the Order, situated at Kato Polemidhia village (hereinafter referred to as "the property"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notification No. 150 published in Supplement No. 3 to the *Gazette* of the 14th February, 1957, the Order was extended for a further period of six months up to the 9th July, 1957 ;

And whereas I am satisfied that the property should continue to be used by the Security Forces for a further period of six months as from the 10th of July, 1957 ;

Now, therefore, in exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, and delegated to me under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, Robert Chattan Ross-Clunis, Commissioner of Limassol, do order that the aforesaid authorization for using the property by the Security Forces subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 10th of July, 1957, and the Order is so extended accordingly.
