## THE TREE PLANTING (VILLAGE AREAS) LAW.

CAP. 175 AND LAW 56 OF 1955.

## ORDER UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Aradhippou in the District of Larnaca on the 14th April, 1957, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Aradhippou.

And whereas Mr. Mattheos Hji Mattheou of the said village who has been appointed under section 14 of this Law has forwarded to me a report signed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law.

Now, therefore, I, the Commissioner of the District of Larnaca, having approved the said report do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the village of Aradhippou.

## SCHEDULE.

*Area " A ".*

The area lying within the following boundaries, that is to say :—

The boundary commences at the most western point of plot No. 55 of the Government Survey Plan No. XL.29, and proceeds north-eastwards along the boundaries of, and including the said plot, plots Nos. 57 and 56 of the said plan, plot No. 1 of the Government Survey Plan No. XL.30, to the most northern point of the said plot, which point is on a footpath; thence south-eastwards along the said footpath up to a point on the eastern boundary of plot No. 18 of the said plan; thence in a south-easterly and south-westerly direction along the boundaries of, and including plot No. 18 (part), 11, 117, 118, 120, 121, 115, 145, 114, 141, 225, 224, 223, 221, 217, 216, 215, 248, 249, 247, 359, 358, 356, 355, 354, 386, 389, 353, 351, 350, 348, 352, 391, 390, 499, and 528 of the said plan, plots Nos. 10, 11, 13 and 12 of the Government Survey Plan No. XL.38, plots Nos. 530, 529 and 531 of the Government Survey Plan No. XL.30, locality " Ayios Constantinos ", plots Nos. 13, 88, 69, 67, 66, 14, 16, 17, 60, 59, 95, 142, 144, 139 (part), 170, 171, 205, 206, 211, 243, 241, and 367 of the Government Survey Plan No. XL.38, to the south-eastern corner of the last mentioned plot which corner is on the junction of streams; thence westwards along the left bank of one of these streams to the bridge carrying Nicosia—Larnaca main road over the said stream; thence north-westwards along the eastern side of the said main road to its junction with a footpath, which junction is at the most eastern point of plot No. 275 of the Government Survey Plan No. XL.29; thence north-westwards and north-eastwards along the said footpath to the south-western corner of plot No. 255 of the said plan; thence in a north-westerly and north-easterly direction along the boundaries of, and including the said plot, plots Nos. 235, 234, 233, 232, 231, 227, 228, 203, 204, 205, 201, 199, 198, 181, 179, 180, 150, 151, 152, 153, 110, 111, 113, 114, 77, 76, 75, 73, 52, 50, 49, 48 and 54 of the said plan to the point of commencement.

*Area " B "*.

The boundary commences at the junction with the Nicosia—Larnaca main road of another road from the village of Aradhippou (near milepost No. 21) and proceeds eastwards along the last mentioned road to the north-eastern corner of plot No. 600 of the Government Survey Plan No. XL.38; thence in a south-easterly direction along the boundaries of, and including the said plot, plots Nos. 599 (part), 685 (part) and 686 of the said plan, plot No. 85 (part) of the Government Survey Plan No. XL.46, plots Nos. 2, 3, 8 (part), 155 (part), 166 (part), 165, 168, 169 (part), 281 (part), 294 (part), 280 (part), 279 (part), 278 (part), 277, 276, 275, 189, 273 and 271 of the Government Survey Plan No. XL.47 to the north-eastern corner of the last mentioned plot, which corner is on a road leading from the village of Aradhippou to the Nicosia—Larnaca main road; thence southwards along the said road to the most southern point of plot No. 864 of the said plan, locality " Kokkines " which point is on the Nicosia-Larnaca main road; thence north-westwards along the eastern side of the said main road to the point of commencement.

*Area " C "*.

The boundary commences at the north-western corner of plot No. 538 of the Government Survey Plan No. XL.39 which corner is on a track leading from the village of Aradhippou to the village of Kellia and proceeds north-eastwards along the said track to the most northern point of plot No. 147 of the said plan, locality " Kalanjes " ; thence in a south-easterly direction along the boundaries of, and including the said plot, plots Nos. 146 and 145 of the said plan, plots Nos. 23, 24, 25, 29, 30, 28, 33 and 32 of the Government Survey Plan No. XL.40, to the most eastern point of the last mentioned plot, which point is on the boundary between the villages of Aradhippou and Kellia; thence eastwards, southwards and westwards along the said boundary to the south-western corner of plot No. 197 of the said plan, locality " Kokkotes " which corner is on a track leading from Larnaca to the village of Aradhippou; thence westwards along the said track to its junction with another track, which junction is at the south-western corner of plot No. 187 of the said plan; thence north-westwards along the last mentioned track to its junction with another track, which junction is at the most western point of plot No. 121 of the said plan; thence westwards along the last mentioned track to its junction with a footpath, which junction is at the south-western corner of plot No. 862 of the Government Survey Plan No. XL.39; thence westwards along the said footpath to the south-eastern corner of plot No. 764 of the said plan; thence northwards along the boundaries of, and including plots Nos. 849 (part), 765, 766 (part), 725 (part), 630, 594 and 538 of the said plan to the point of commencement.

The boundaries of the said areas " A ", " B " and " C " are more particularly delineated in red on the Government Survey Plan Serial No. 1693 and include an area 3,122 donums or thereabouts.
