THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)  
LAWS, 1950 AND 1953.

BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF TRIKOMO.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Trikomo hereby make the following bye-laws:—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Trikomo (Amendment) Bye-laws, 1957, and shall be read as one with the Villages (Administration and Improvement) Trikomo Bye-laws, 1951 and 1956 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Trikomo Bye-laws, 1951 to 1957.

2. The Second Appendix to the principal Bye-laws is hereby amended by the deletion therefrom of the words "The proviso to this bye-law to be deleted" in the fifth line.

3. The proviso to paragraph 117 of the principal Bye-laws is hereby amended by the deletion therefrom of the words "three shillings" in the fifth line thereof and the substitution therefor of the words "250 mils".

The above bye-laws have been approved by the Acting Administrative Secretary.
