REVOCATION OF ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, and the powers vested in me by Regulation 69, I hereby revoke with effect from the 12th August, 1957, without prejudice to anything done or left undone thereunder, the Order made by me on the 11th day of December, 1956, and published in Supplement No. 3 to the *Gazette* of the 27th December, 1956, under Notification No. 1271.

THE CURFEWS LAWS, 1955.
LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Famagusta District No. 8) Order, 1957.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 26th day of July, 1957.

Within the village area of Ayios Theodoros.

SECOND SCHEDULE.

From 03.00 hours until 10.00 hours on 26th July, 1957.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 3) 1957.

ORDER UNDER REGULATION 35A.

Whereas it has come to my notice that illegal slogans have been painted on the main road from Boghaz to Rizokarpaso between the forty-third and forty-fourth milestones, now, therefore I, the Commissioner of Famagusta, in exercise of the powers conferred upon me by Regulation 35A of the

Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, do hereby order as follows:—

1. This Order may be cited as the Removal of Illegal Slogans from Roads (Famagusta District No. 4) Order, 1957.
2. The use of the Boghaz to Rizokarpaso main road between the forty-third and forty-fourth milestones is prohibited.
3. This Order shall come into force at 03.00 hours on Friday, 26th July, 1957, and shall remain in force until further notice.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1957.**

ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorize its use in the interest of public order and safety:

Now, therefore, in exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, which I have been authorized to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Limassol, hereby take possession of the land and, in connection with the taking possession and making use of the land, I hereby direct and order as follows:—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorized.
- (2) The persons using the land in pursuance of this Order are hereby authorized to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.
