

No. 776. THE LAND ACQUISITION LAW.
CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTICE UNDER SECTION 6.

With reference to Notification No. 768 published in Supplement No. 3 to the *Gazette* of the 8th August, 1957, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

All those areas of privately owned lands, with everything standing thereon, situated at Ktima Town, comprising 4 donums, 3 evleks and 2,500 square feet or thereabouts, under plots Nos. 38/1 and 38/2 of the Government Survey Plan No. I.I.3.2.I., more particularly defined as the area delineated in red on the plan signed by the Director of Public Works and dated the 20th June, 1957.

2. Any person claiming to have any right or interest in the said lands, who objects to the acquisition, is required within three weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office.

5. The period mentioned in paragraph 2 hereof has been abridged to three weeks with the approval of His Excellency the Governor.

No. 777. THE FORESHORE PROTECTION LAW.
CAP. 92 AND LAW 16 OF 1954.

NOTICE UNDER SECTION 3 (1).

In exercise of the powers vested in me by section 3 (1) of the Foreshore Protection Law, I do hereby prohibit the removal of stones, gravel, shingle, sand or other substances, save under a written permit from me and under such conditions as I may impose thereby, from those areas of the foreshore described in Schedules I and II hereto.

SCHEDULE I.

Commencing at the intersection of the western boundary of Larnaca District with the foreshore and proceeding thence in a north-easterly direction to a point situated on the foreshore at CAPE MAZOTOS at G.R.S. 163250 on map GSGS.4242 Sheet 13 Edition 4.

SCHEDULE II.

Commencing at a point situated on the foreshore at G.R.S. 450464 on map GSGS.4242 Sheet 13 Edition 4 and proceeding thence in a south-easterly direction to CAPE PYLA, and thence in a north-easterly direction to the intersection of the eastern boundary of Larnaca District with the foreshore.
