

No. 826. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 4) 1957.

ORDER MADE UNDER REGULATION 38 (1).

I, the Commissioner of Larnaca, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 4) 1957, do hereby order as follows :—

(1) This Order may be cited as the Protected Areas (Larnaca District No. 1) Order, 1957.

2. The areas specified in the Schedules hereto and delineated in red on the plan dated August 14th, 1957, and signed by the Commissioner of Larnaca, is hereby declared to be a protected area for the purpose of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955.

SCHEDULE I.

That area of the Port and Harbour of Larnaca (including all port works, buildings and installations adjoining or situated therein) bounded on the north by the Export Pier, on the south by the Main Pier, on the east by the Main Pierhead Breakwater and on the west by the eastern edge of the roadway connecting the Main Pier and the Export Pier, together with all waters enclosed thereby and by lines drawn from the extremities of the Export Pier and the Main Pierhead Breakwater in prolongation of them in an easterly and northerly direction respectively to the point at which they intersect.

SCHEDULE II.

All that area of water within a distance of ten yards to the northward from the Export Pier, within a distance of ten yards to the eastward from the Main Pierhead Breakwater and within a distance of ten yards to the southward from the Main Pier.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955.

ORDER MADE UNDER REGULATION 38 (1).

I, the Commissioner of Famagusta, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955, do hereby order as follows :—

1. This Order may be cited as the Protected Areas (Famagusta District No. 2) Order, 1957.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purpose of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955.

3. This Order shall come into force at 04.00 hours on the 11th August, 1957 and shall remain in force until 18.00 hours on the same day unless revoked or extended by a supplementary order under my hand.

SCHEDULE.

The area lying within village boundaries of Lyssi.

No. 828. THE LAND ACQUISITION LAW.
CAP. 233 AND LAWS 26 OF 1952 AND 22 OF 1956.

NOTICE UNDER SECTION 6.

With reference to Notification No. 154 published in Supplement No. 3 to the *Gazette* of the 1st March, 1956, notice is hereby given that the following land is required for the undertaking of public utility mentioned therein :—

All the privately-owned land with everything standing thereon, situated at Akhna village, comprising 700 square feet or thereabouts, and forming part of plot No. 219 of the Government Survey Plan No. XXXII.39, more particularly defined as the area coloured red on the plan signed by the Director of Public Works and dated the 29th July, 1957.

2. Any person claiming to have any right or interest in the said land who objects to the acquisition is required within ten days from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said land.

4. A plan showing the land described above is available for inspection at my office.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.
