No. 850. THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAWS, 1950 AND 1953.

Bye-laws made by the Improvement Board of Kophinou.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Kophinou hereby make the following bye-laws :---

1. These bye-laws may be cited as the Villages (Administration and Improvement) Kophinou (Amendment) Bye-laws, 1957, and shall be read as one with the Villages (Administration and Improvement) Kophinou Bye-laws, 1953 and 1956 (hereinafter referred to as "the principal Bye-laws") and the principal bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Kophinou Bye-laws, 1953 to 1957.
