THE SOIL CONSERVATION LAWS, 1952 AND 1956.

NOTICE UNDER SECTION 9.

Pursuant to section 9 of the Soil Conservation Laws, 1952 and 1956, it is hereby notified that with the approval of the Governor, a Soil Conservation Division has been formed at Philia and Masari villages in respect of the area lying within the following boundaries, that is to say:—

The boundary commences at the north-western corner of plot No. 365 of the Government Survey Plan No. XX.35, locality "Alonia", which corner is on the road leading from the village of Masari to the village of Philia and proceeds north-eastwards along the said road to the north-eastern corner of plot No. 655 of the Government Survey Plan No. XX.36, locality "Kaphkalia"; thence south-eastwards along the boundary of and including the said plot, plots Nos. 648, 645, 647, 641, 639, 631 and 624/1, to the most northern point of plot No. 624/2 of the said plan, which point is on a track leading from the village of Philia to the village of Avlona; thence south-eastwards along the said track to the most eastern point of plot No. 75 of the Government Survey Plan No. XX.44, locality "Kaphkalla tis Toumbas"; thence south-westwards and north-westwards along the boundary of and including the said plot, plots Nos. 78 (part), 76/2, 77, 69, 68 (part), 61/2, 63/2 and 63/1 of the said plan, to the south-western corner of the last mentioned plot, which corner is on the road leading from the village of Philia to the village of Peristerona; thence north-eastwards along the said road to the south-western corner of plot No. 59 of the said plan, locality "Paliambela"; thence north-westwards to the north-eastern corner of plot No. 55 of the said plan; thence south-westwards along the northern boundaries of plots Nos. 55 and 48 of the said plan to the south-eastern corner of plot No. 49 of the said plan; thence north-westwards along the boundary of and including the said plot, plots Nos. 724, 725 of the Government Survey Plan No. XX.36, locality "Kakoskalin", 358, 360, 363, 369 and 370 of the Government Survey Plan No. XX.35, locality "Alonia", to the south-western corner of the last mentioned plot; thence north-eastwards along the boundary of and including the said plot, plots Nos. 371, 367 and 365 of the said plan to the point of commencement, all which said area is shown edged in red on the Government Survey Plan signed by the Director of Agriculture, dated the 19th August, 1957, and deposited in his office at Nicosia.

And that the Soil Conservation Scheme briefly set out in the Appendix hereto will be in operation within the aforesaid area.

APPENDIX.

The "kafkala" land will be ripped and cross-ripped, and the stones to be extracted will be used for the construction of contour banks designed to protect the improved lands against erosion.

The total cost of the scheme has been estimated at about £7,200.
