In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :---

1. This Order may be cited as the Curfews (Nicosia District No. 4) Order, 1957.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force, British expatriates and holders of permanent curfew passes.

This Order shall come into force on the 22nd day of January, 1957.

1. This Order may be cited as the Curfews (Nicosia District No. 5) Order, 1957.

2. No person within the area prescribed in the Schedule hereto shall be out of doors as from 05.00 hours on 23rd of January, 1957, until further notice, except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any person who is not a Turkish Cypriot male born on or after 1st January, 1936.

3. This Order is in addition to and not in derogation of the Order dated 5th day of November, 1956, published as Notification No. 1061 in Supplement No. 3 to the *Gazette* of 8th November, 1956, as amended by Notification No. 19 dated 24th December, 1956, and published in Supplement No. 3 to the *Gazette* of 3rd January, 1957.

SCHEDULE.

The whole of that part of Nicosia commonly known as the Walled City of Nicosia.
