ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 24th April, 1956, and published in Supplement No. 3 to the *Gazette* of the 7th June, 1956, under Notification No. 468 (as amended by Notification No. 859 published in Supplement No. 3 to the *Gazette* of the 12th September, 1957) (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Kato Kyrenia (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 1165 and 400 published in Supplement No. 3 to the *Gazettes* of the 29th November, 1956, and 11th April, 1957, respectively, the Order was extended for further periods of six months up to the 23rd October, 1957 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1956), His Excellency the Governor has been pleased to order and hereby orders that the aforesaid authorisation for using the land for military purposes subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 24th October, 1957, and the Order is so extended accordingly.
