THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 4) 1957.

ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorize its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 4) 1957, which I have been authorised to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Limassol, hereby take possession of the land and, in connection with the taking possession and making use of the land, I hereby direct and order as follows :—

- (1) The use of the land for the requirements of the Electricity Authority, Cyprus, is hereby authorised.
- (2) The persons using the land in pursuance of this Order are hereby authorised to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

SCHEDULE.

All that privately owned land in Limassol town, being parts of Plots Nos. 78/2, 78/3, 78/4, 78/12 & 78/13 on the Government Survey Sheet/Plan No. LIV/58.2.I, and more particularly defined as the area coloured red on the Plan signed by the Commissioner of Limassol and dated 18th September, 1957, a copy of which is available for inspection at the Office of the Commissioner of Limassol.

THE CURFEWS LAWS, 1955.  
LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Famagusta District No. 10) Order, 1957.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 22nd day of September, 1957.

THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND CONTROL) LAW.

CAP. 157.

NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 15th October, 1957, and 31st January, 1958, flocks within the village area of Vavla in the District of Larnaca, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.
