Magistrate, while sitting at Morphou or Nicosia, be increased from fifty pounds to one hundred pounds.

THE LAND ACQUISITION LAW.

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTIFICATION UNDER SECTION 7.

Whereas by Notification No. 453 published in Supplement No. 3 to the Gazette of the 18th April, 1957, the Governor's Deputy declared the installation and operation of a non-Directional Beacon at Dhiorios village to be an undertaking of public utility;

And whereas the Commissioner of Nicosia and Kyrenia in compliance with section 6 of the Land Acquisition Law by a notice published under Notification No. 587 in Supplement No. 3 to the Gazette of the 6th June, 1957, gave particulars of the land required in connection with the aforesaid undertaking (hereinafter referred to as "the land");

And whereas the Commissioner of Nicosia and Kyrenia forwarded to the Governor the required recommendations, plan and particulars, no objections having been made;

And whereas the Governor has approved the plan and particulars submitted, and has considered it expedient, having regard to the circumstances of the case, that the land be acquired :

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition of the land under the provisions of the said Law.

THE PRISON DISCIPLINE LAW. No. 941 CAP. 266 AND LAW I OF 1953.

PRISONS (PRISON SERVICE) (AMENDMENT) REGULATIONS.

In exercise of the powers vested in him by section 6 of the Prison Discipline Law, His Excellency the Governor with the advice of the Executive Council has been pleased to make the following regulations :-

1. These Regulations may be cited as the Prisons (Prison Service) (Amendment) (No. 2) Regulations, 1957, and shall be read as one with the S.L. Vol. I. Prisons (Prison Service) Regulations (hereinafter referred to as "the p. 588. principal Regulations ").

2. Regulation 11 of the principal Regulations is hereby amended by the substitution for the words "two pounds" in the second line of the proviso to sub-paragraph (a) thereof of the words "ten pounds".
