NOTICE UNDER SECTION 17 (7).

With reference to the notice published under No. 864 in the *Gazette* of 2nd August, 1956, as amended by notice No. 594 published in the *Gazette* of 16th May, 1957, it is hereby notified for general information that, after considering the plans and specifications concerning the streets enumerated under column (1) of the Schedule hereto and objections made, the Governor, with the advice of the Executive Council, has been pleased to approve the plans and specifications concerning the said streets to the extent shown under column (2) of the Schedule hereto.

2. The plans and specifications in respect of the streets set out in the Schedule hereto shall, subject to the conditions shown under column (2) of the Schedule, be binding on the Municipal Council of Nicosia and upon all owners affected.
