BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF ZYYI.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Zyyi hereby make the following bye-laws :-

1. These bye-laws may be cited as the Villages (Administration and Improvement) Zyyi (Amendment) Bye-laws, 1957, and shall be read as one with the Villages (Administration and Improvement) Zyyi Bye-laws, 1951 to 1956 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Zyyi Bye-laws, 1951 to 1957.

2. The Second Schedule (Bye-law 177) to the principal Bye-laws is hereby amended by the deletion therefrom of items 7 and 8 and the substitution therefor of the following :----

THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAWS. 1949 AND 1954.

In pursuance of the provisions of section 12 (3) of the Irrigation (Private Water) Association Laws, 1949 and 1954, the following rules made by the Committee of the Irrigation Association of Pharmakas ("Koskinas" water), in the District of Nicosia, are published in the Gazette,

IRRIGATION ASSOCIATION OF PHARMAKAS ("KOSKINAS" WATER). Rules.

Gazette :

1. These rules may be cited as the Irrigation Association of Pharmakas Suppl. No.3: ("Koskinas" water) (Amendment) Rules, 1957, and shall be read as one 14.5.1952. with the Irrigation Association of Pharmakas ("Koskinas" water) Rules, 1952 (hereinafter referred to as "the principal Rules") and the principal Rules and these Rules may together be cited as the Irrigation Association of Pharmakas ("Koskinas" water) Rules, 1952 and 1957.

2. Rule 6 (3) of the principal Rules is hereby amended by the deletion therefrom of the words "The treasurer shall be unpaid : Provided that he shall be paid such of his out of pocket expenses as may be sanctioned by the Committee" and the substitution therefor of the words "The treasurer shall receive a remuneration of 6% of all rates and charges collected by him as in paragraph (1) hereof, and, in addition, he shall be paid such of his out of pocket expenses as may be sanctioned by the Committee".
