CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTICE UNDER SECTION 6.

With reference to Notification No. 812 published in Supplement No. 3 to the *Gazette* of the 29th August, 1957, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

All those areas of privately-owned lands, with everything standing thereon, situated at Pano Kyrenia, Quarter of Kyrenia Town, comprising 20 donums or thereabouts, being plots Nos. 216/5, 216/6/1, 216/6/2, 217, 218, 219 and 220 of the Government Survey Plan No. XII.21, more particularly defined as the area coloured red on the plan signed by the Chairman of the Governing Body for Moslem Secondary Schools, Kyrenia, and dated the 21st October, 1957.

2. Any person claiming to have any right or interest in the said lands, who objects to the acquisition is required within six weeks from the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Governing Body for Moslem Secondary Schools, Kyrenia, is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office in Kyrenia.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 4) 1957.**

I, the Commissioner of Famagusta, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 4) 1957, do hereby order as follows :—

1. This Order may be cited as the Protected Areas (Famagusta District No. 11) Order, 1957.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purposes of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 4) 1957.

3. This Order shall come into force at 05.00 hours on Sunday, 20th October, 1957, and shall remain in force until 13.00 hours on Sunday, 20th October, 1957, unless revoked or extended by a supplementary order under my hand.

The area lying within the village area of Dherinia.
