Whereas by Order dated the 3rd October, 1956, and published in Supplement No. 3 to the Gazette of the 11th October, 1956, under Notification No. 964 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Arab Ahmed Quarter, Nicosia (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months;

And whereas by virtue of Notifications Nos. 220, 888 and 224 published in Supplement No. 3 to the Gazettes of the 28th February, 1957, 26th September, 1957 and 3rd April, 1958, respectively, the Order was extended for further periods of six months up to the 2nd October, 1958;
