

No. 1028. THE BOMBARDMENT RANGE AREAS LAW.
CAP. 222 AND LAW 23 OF 1951.

REGULATIONS UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Bombardment Range Areas Law, His Excellency the Governor hereby makes the following Regulations :—

23 of 1951.

1. These Regulations may be cited as the Bombardment Range Areas (Consolidation) (Amendment) Regulations, 1958, and shall be read as one with the Bombardment Range Areas (Consolidation) Regulations, 1957, (hereinafter referred to as "the principal Regulations") and the principal Regulations and these Regulations may together be cited as the Bombardment Range Areas (Consolidation) Regulations, 1957 and 1958.

2. The principal Regulations are hereby amended by deleting regulation " 19 " therein and substituting therefor the following new regulation to be numbered " 19 " :—

" 19. The Goshi Bombardment Range Area shall be used only by day and the signals to be hoisted in respect thereof shall be as follows :—

- (i) A red flag hoisted on the highest point of the high ground at the SOUTH-EASTERN boundary of the area.
- (ii) Red flags hoisted on the approaches to the area at points on the map 1 : 50,000 Cyprus, Sheet 13, Larnaca, map reference 231488, 235475, 231455, 172509, 171508."

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in His Excellency the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Bertram John Weston, Commissioner of Nicosia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the community, have taken possession with immediate effect of the premises specified in the Schedule hereto until further notice.

2. The use of the said premises for the requirements of Her Majesty's Forces is hereby authorised.

3. The authority using the premises in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary for the purpose of their occupation.

4. The exercise of any right of way over the premises and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the premises or otherwise is hereby prohibited during the period this Order shall remain in force.

SCHEDULE.

All that privately owned property situated in Nicosia Town standing on plot 43, Sheet/Plan XXI.46.5.IV, Block 25, Trypiotis Quarter, known as "The Trust Club", more particularly defined as the area coloured red on the plan signed by the Commissioner of Nicosia and Kyrenia and dated the 14th November, 1958.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.**

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Nicosia, do hereby make the following Order :—

1. This Order may be cited as the Control of Bicycles, Motor Cycles and Motor Scooters (Nicosia District) (No. 1) Order, 1958.

2. The use or circulation of any bicycle, motor cycle or motor scooter by Greek Cypriot males within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the officer in charge of Nicosia Police Division :

Provided that this paragraph shall not apply to :

(a) Members of Her Majesty's Forces.

(b) Members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.

(c) Persons who can prove that they were born before the 1st of August, 1931, or after the 31st day of July, 1948.
