No. 1071. THE CRIMINAL PROCEDURE (TEMPORARY PROVISIONS) LAW, 1955.

ORDER IN COUNCIL No. 3046

MADE UNDER SECTION 5.

In exercise of the powers vested in him by the proviso to section 5 of the Criminal Procedure (Temporary Provisions) Law, 1955, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

- 1. This Order may be cited as the Criminal Procedure (Temporary Provisions) (Continuance) (No. 2) Order, 1958.
- 2. The Criminal Procedure (Temporary Provisions) Law, 1955, as amended by the Emergency Powers (Amendment of Law No. 40 of 1955) Regulations, 1956, and by the Emergency Powers (Amendment of Law No. 40 of 1955) (No. 2) Regulations, 1956, shall continue in operation for a period of six months from the 1st day of January, 1959, that is until the

30th day of June, 1959, and shall then expire unless continued in force for any further period or periods of six months by the Governor in Council, by Order published in the *Gazette*, under the provisions of the proviso to section 5 of the said Law.
