

**No. 1082. THE ELEMENTARY EDUCATION LAW.**

CAP. 203 AND LAWS 22 OF 1950, 17 OF 1952, 28 OF 1953, 12 OF 1954,

## ORDER UNDER SECTION 6 (2).

In exercise of the powers vested in him by section 6 (2) of the Elementary Education Law the Governor does hereby order as follows :—

1. This Order may be cited as the Elementary Education (Prescription of Groups) (Amendment) Order, 1958, and shall be read as one with the Elementary Education (Prescription of Groups) Orders, 1956 and 1957 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Elementary Education (Prescription of Groups) Orders, 1956 to 1958.

2. The First Schedule to the principal Order is hereby amended by the insertion therein immediately after the words "Greek Orthodox, Khrysiliou, Morphou," of the following words in their respective columns "Greek Orthodox, The area of Strovolos village known as Acropolis Quarter and defined in the Schedule hereto, Nicosia."

## SCHEDULE.

The area lying within the following boundary, that is to say :—

The boundary commences at the most northern point of plot No. 322 of Block "J", Strovolos village, which point is on the boundary between the village of Strovolos and the town of Nicosia and proceeds in an easterly direction along the said boundary to the north-western corner of plot No. 172 of Block "N", Strovolos village, which corner is on Glafkos Street ; thence south-eastwards along the said street to its junction with Arsinoe Street ; thence south-eastwards along the last mentioned street to the most western point of plot No. 459 of the said Block, which point is on a road ; thence north-eastwards along the said road to the western boundary of plot No. 933 of the said Block ; thence northwards along the western boundary of the said plot to its north-western corner, which corner is on a road ; thence eastwards along the said road to the north-eastern corner of plot No. 954 of the said Block ; thence southwards along the boundaries of and including the said plot, plots Nos. 955, 956, 957, 972 and 364 of the said Block to the south-eastern corner of the last mentioned plot, which corner is on the Nicosia-Limassol main road ; thence southwards along the said main road to its junction with Athalassa Avenue ; thence north-westwards along the said Avenue to the south-western corner of plot No. 314 of Block "J", Strovolos village ; thence northwards and north-eastwards along the boundaries of and including the said plot and plot No. 322 of the said Block to the point of commencement, all which said area is shown edged red on the Government Survey Plan, Serial No. 1716.
