

**No. 1083. THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 25th June, 1958, and published in Supplement No. 3 to the *Gazette* of the 3rd July, 1958, under Notification No. 436 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in Famagusta town (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor has authorized the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 25th December, 1958.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 31st December, 1956, and published in Supplement No. 3 to the *Gazette* of the 10th January, 1957, under Notification No. 36 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Kato and Pano Lakatamia villages (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;
