

**No. 1086. THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 9th June, 1956, and published in Supplement No. 3 to the *Gazette* of the 14th June, 1956, under Notification No. 511 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Yerolakkos village, (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 1165, 576, 1048 and 362 published in Supplement No. 3 to the *Gazettes* of the 29th November, 1956, 6th June, 1957, 28th November, 1957 and 12th June, 1958, respectively, the Order was extended for further periods of six months up to the 8th December, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :
