## ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 22nd June, 1956, and published in Supplement No. 3 to the Gazette of the 28th June, 1956, under Notification No. 595 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Yermasovia village (hereinafter referred to as "the land "), subject to the restrictions and conditions therein laid down for a period of six months ;

Now, therefore, in exercise of the powers vested in him by Defence Gazette : Regulation 64, as set out in the First Schedule to the Supplies and Services Supplement (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor has authorized the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 22nd December, 1958.

Whereas by Order dated the 11th December, 1956, and published in Supplement No. 3 to the *Gazette* of the 13th December, 1956, under Notification No. 1224 (as amended by Notification No. 256 published in Supplement No. 3 to the Gazette of the 17th April, 1958) (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village areas of Kalopsidha, Makrasyka and Akhna in the Famagusta District and Xylotymbou and Pyla in the Larnaca District (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months;

And whereas by virtue of Notifications Nos. 580, 1051, and 357 published in Supplement No. 3 to the *Gazettes* of the 6th June, 1957, 28th November, 1957 and 12th June, 1958, respectively, the Order was extended for further periods of six months up to the 10th December, 1958;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor has authorized the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 11th December, 1958.
