### ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in me by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1958, I, Bertram John Weston, Commissioner of Nicosia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the community, I have taken possession with immediate effect of the premises and land specified in the Schedule hereto until further notice.

2. The use of the said premises and land for the requirements of Her Majesty's Forces is hereby authorised.

3. The authority using the premises and land in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary

for the purpose of their occupation.

4. The exercise of any right of way over the premises and land and of any other right relating thereto which is enjoyed by any person whether by virtue of an interest in the premises and land or otherwise is hereby prohibited during the period this Order shall remain in force.

- 1. This Order may be cited as the Control of Passenger Vehicles (Nicosia District) (No. 1) Order, 1958.
- 2. The use or circulation of any omnibus or public service vehicle licensed to carry more than six passengers is hereby prohibited within the area set out in the Schedule hereto.
- 3. This Order shall come into force at ooo1 hours on the 3rd day of December, 1958.

# Order made under Regulation 34.

In exercise of the powers vested in me under paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Limassol, do hereby make the following Order:-

1. This Order may be cited as the Control of Bicycles, Motor Cycles

and Motor Scooters (Limassol District) (No. 2) Order, 1958.

2. The use or circulation of any bicycle, motor cycle and motor scooters within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the Assistant Chief Constable in charge of the Limassol Police Division:

Provided that this paragraph shall not apply to :-

(a) any member of Her Majesty's Forces or of the Cyprus Police Force (which term for the purposes of this Order includes the Auxiliary Police Force and the Police Fire Service) and any Special Constable when on duty as such;

(b) persons born on or before the 1st August, 1931.

3. No motor cycle or bicycle shall be left in any street or place to which the public have access in the area specified in the Schedule hereto.

4. This Order shall come into force at 0500 hours on the 9th day of

November, 1958. 5. The Control of Pedal Bicycles (Limassol District) (No. 1) Order, 1958, dated the 24th day of July, 1958, is hereby revoked.
