**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 5) 1958.**

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in me under paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Limassol, do hereby make the following Order :—

1. This Order may be cited as the Control of Bicycles, Motor Cycles and Motor Scooters (Limassol District) (No. 2) Order, 1958.

2. The use or circulation of any bicycle, motor cycle and motor scooters within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the Assistant Chief Constable in charge of the Limassol Police Division :

Provided that this paragraph shall not apply to :—

(a) any member of Her Majesty's Forces or of the Cyprus Police Force (which term for the purposes of this Order includes the Auxiliary Police Force and the Police Fire Service) and any Special Constable when on duty as such ;

(b) persons born on or before the 1st August, 1931.

3. No motor cycle or bicycle shall be left in any street or place to which the public have access in the area specified in the Schedule hereto.

4. This Order shall come into force at 0500 hours on the 9th day of November, 1958.

5. The Control of Pedal Bicycles (Limassol District) (No. 1) Order, 1958, dated the 24th day of July, 1958, is hereby revoked.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 6) 1958.**

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in me by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1958, I, the Commissioner of Limassol District, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Control of Motor Vehicles by Night) (Limassol District) (No. 3) Order, 1958.

2. Notwithstanding anything in any Law or Public Instrument contained, from and after the 21st day of November, 1958, no motor vehicle shall be used on any road within the Limassol District between the hours of 1800 p.m. and 0500 a.m. unless the person driving such vehicle is in possession of a permit granted to him by the Commissioner or by the Assistant Chief Constable in charge of the area, and subject to such terms and conditions as may be specified in such permit :

Provided that this paragraph shall not apply to the use of any motor vehicle within any area set out in the Schedule hereto.

3. Nothing in this Order contained shall apply to—

(a) a member of Her Majesty's Forces, or

(b) a Police Officer acting in the course of his duty as such, or

(c) any person who is not a member of the Greek Cypriot community.

4. This Order shall come into force on the 21st day of November, 1958.

5. The Emergency Powers (Control of Motor Vehicles by Night) (Limassol District) (No. 2) Order, 1958, is hereby revoked.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 5) 1958.**

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in me by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Famagusta District, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Control of Motor Vehicles by Night) (Famagusta District) (No. 3) Order, 1958.

2. Notwithstanding anything in any Law or Public Instrument contained, from and after the 21st day of November, 1958, no motor vehicle shall be used on any road within the Famagusta District between the hours of 6.00 p.m. and 05.00 a.m. unless the person driving such vehicle is in possession of a permit granted to him by the Commissioner or by the Assistant Chief Constable in charge of the area, and subject to such terms and conditions as may be specified in such permits :

Provided that this paragraph shall not apply to the use of any motor vehicle within any area set out in the Schedule hereto.

3. Nothing in this Order contained shall apply to any person acting in the course of his duty as—

(a) a member of Her Majesty's Forces, or

(b) police officer.

4. This Order shall come into force on the 21st day of November, 1958.

5. The Emergency Powers (Control of Motor Vehicles by Night) (Famagusta District) (No. 2) Order, 1958, is hereby revoked.
