

No. 1109.**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 5) 1958.****ORDER UNDER REGULATION 34.**

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Famagusta, do hereby make the following Order :—

1. This Order may be cited as the (Famagusta District) (Control of Bicycles) (No. 4) Order, 1958, and shall come into force on the 9th day of November, 1958.

2. The use or circulation of any bicycle, motor cycle, or motor scooter by any Greek Cypriot within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the officer in charge of Famagusta Police Division :

Provided that this paragraph shall not apply to—

(a) members of Her Majesty's Forces,

(b) members of the Cyprus Police Force (as defined in the Police Law) when on duty as such,

(c) persons who can prove that they are under the age of ten years or over the age of twenty-seven years.

3. No bicycle, motor cycle, or motor scooter shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.

4. The Famagusta District (Control of Bicycles) (No. 3) Order, 1958, is hereby revoked.

REGULATIONS, 1955 TO (No. 5) 1958.****ORDER MADE UNDER REGULATION 34.**

In exercise of the powers vested in me by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Assistant Commissioner of Kyrenia District, do hereby make the following Order :—

1. This Order may be cited as the Emergency Powers (Control of Motor Vehicles by Night) (Kyrenia District) (No. 2) Order, 1958.

2. Notwithstanding anything in any Law or Public Instrument contained, from and after the 21st day of November, 1958, no motor vehicle shall be used on any road within the Kyrenia District between the hours of 6.00 p.m. and 5.00 a.m. unless the person driving such vehicle is in possession of a permit granted to him by the Assistant Commissioner of Kyrenia or by the Superintendent of Police in charge of the area, and subject to such terms and conditions as may be specified in such permit :

Provided that this paragraph shall not apply to the use of any motor vehicle within any area set out in the Schedule hereto.

3. Nothing in this Order contained shall apply to any person acting in the course of his duty as—
 (a) a member of Her Majesty's Forces, or
 (b) a police officer.
4. This Order shall come into force on the 21st November, 1958.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)

ORDER MADE UNDER REGULATION 39A.

Whereas I, the Assistant Commissioner of the District of Kyrenia, am satisfied that the building described in the Schedule hereto (hereinafter referred to as "the building") is a building which is being used by terrorists, now, therefore, in exercise of the powers vested in me by Regulation 39A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, with the approval of the Governor, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Forfeiture and Demolition) (Kyrenia District) (No. 2) Order, 1958, and shall come into force on the 5th day of November, 1958.
2. It is hereby directed that the building and its contents be forfeited and demolished.

SCHEDULE.

The building situated at Karavas (Pano Yitonia Quarter) in the District of Kyrenia standing on Plot No. 31, of Government Survey Plan 11/24 and registered under No. 1483 of 20th September, 1933.
