ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Famagusta District)(No.57) Order, 1958.

2. No female Greek Cypriot born between the 1st January, 1932 and the 1st January, 1944, and no male Greek Cypriot shall be out of doors, within the area prescribed in the First Schedule hereto, between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area:

Provided that this Order shall not apply to :—

- (a) any member of the Executive Council ;
- (b) any member of Her Majesty's Forces or of the Cyprus Police Force (which term for the purposes of this Order includes the Auxiliary Police Force and the Police Fire Service) and any Special Constable when on duty as such ;
- (c) any person holding a summons to appear before a Special Court, established under the Special Court Laws, 1955 to 1957, when proceeding to and from the Court in accordance with such summons ;
- (d) any advocate in possession of a certificate issued by a Justice of the Special Court or by the Registrar of the Special Court, Nicosia, that he is briefed to appear in the Special Court on a specified date when such advocate is proceeding to and from such Court on such date.
- (e) through traffic passing Paralimni village.

3. This Order shall come into force on the 25th November, 1958.

FIRST SCHEDULE.

The built-up area of Palimni village including a radius of one mile beyond the village outskirts.

SECOND SCHEDULE.

From 0730 hours till 0930 hours and from 1430 hours till 1630 hours daily.

ORDER MADE UNDER SECTION 2.

1. This Order may be cited as the Curfews (Famagusta District)(No. 58) Order, 1958.

2. No male Greek Cypriot born between the 1st January, 1932 and the 1st January, 1944, shall be out of doors, within the area prescribed in the First Schedule hereto, between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area:

Provided that this Order shall not apply to:—

- (a) any member of the Executive Council;
- (b) any member of Her Majesty's Forces or of the Cyprus Police Force (which term for the purposes of this Order includes the Auxiliary Police Force and the Police Fire Service) and any Special Constable when on duty as such;
- (c) any person holding a summons to appear before a Special Court, established under the Special Court Laws, 1955 to 1957, when proceeding to and from the Court in accordance with such summons;
- (d) any advocate in possession of a certificate issued by a Justice of the Special Court or by the Registrar of the Special Court, Nicosia, that he is briefed to appear in the Special Court on a specified date when such advocate is proceeding to and from such Court on such date.

3. This Order shall come into force on the 25th November, 1958.

The municipal area of Famagusta town.

SECOND SCHEDULE.

From 0745 hours till 0830 hours and from 1345 hours till 1430 hours daily except Sundays starting 25th November, and from 1700 hours till 0500 hours nightly.

The Curfews (Famagusta District) (No. 56) Order, 1958, is hereby revoked.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows:—

1. This Order may be cited as the Curfews (Lefka Area) (No. 21) Order, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Lefka or the Assistant Commissioner of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.
