### THE IRRIGATION DIVISIONS (VILLAGES) LAW. CAP. 111.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, Cap. 111, the following rules made by the Committee of the Irrigation Division of Ayia Varvara in the District of Paphos, are published in the Gazette.

#### IRRIGATION DIVISION OF AYIA VARVARA (PAPHOS). Rules.

- 1. These Rules may be cited as the Irrigation Division of Ayia Varvara (Paphos District) Rules, 1957.

  - 2. In these Rules, unless the context otherwise requires—
    "Commissioner" means the Commissioner of the District of Paphos.
  - "Commissioner" means the Commissioner of the District of raphos.
    "Committee" means the Committee of the Irrigation Division.
    "Irrigation Division" means the Irrigation Division of Ayia Varvara, Paphos.
    "Law" means the Irrigation Divisions (Villages) Law, Cap. 111.
    "List" means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared
    - under the provisions of section 16 of the Law as finally settled;
      "Works" means the irrigation works of the Irrigation Division and includes the water to be leased from Government for the purposes of the said works.
