

corner of plot No. 724 of the Government Survey Plan No. XXIX.20, locality "Kokkinopetra"; thence north-westwards in a straight line to the most southern point of plot No. 194 of the said plan; thence south-westwards in a straight line to the south-eastern corner of plot No. 317 of the said plan, which corner is on a track leading from the village of Orounda to the village of Potami; thence in a westerly direction along the said track to its junction with another track, which junction is at the most western point of plot No. 159 of the Government Survey Plan No. XXIX.18 thence north-westwards in a straight line to the Government Survey triangulation point No. 139/4 on the said plan; thence westwards in a straight line to the most southern point of plot No. 24 of the said plan which point is on a road leading from the village of Potami to the Nicosia-Lefka main road; thence north-westwards along the said road to the said main road; thence in a westerly direction along the said main road to the mile post No. 27; thence westwards in a straight line to the north-western corner of plot No. 89 of the Government Survey Plan No. XXVIII.4, locality "Marathies", which corner is on the most southern point of the Water Conservation Area, the boundaries of which were published under Notification No. 1052 of Supplement No. 3 to the *Cyprus Gazette* of 1956; thence north-eastwards and northwards along the eastern boundary of the said Water Conservation Area to the point of commencement, all which boundary is more particularly delineated on a plan marked Serial No. 1700 signed by the Commissioner of Nicosia and Kyrenia bearing date 23rd January, 1958, and deposited at the Office of the Commissioner of Nicosia and Kyrenia.

**No. 170. THE MISSIONARY EDUCATIONAL AND MEDICAL
(ALIEN REGULATION) LAW, CAP. 124.**

PERMIT UNDER SECTION 8.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Law, the persons whose names appear in the Schedule hereto have applied for permits under the provisions of the said Law;

And whereas the said persons have severally given an undertaking in writing to pay all due obedience and respect to the Government of Cyprus and, while carefully abstaining from participation in political affairs, that they desire and purpose *ex animo* to work in friendly co-operation with the said Government in all matters in which their influence might properly be exerted; and, they have undertaken that, if engaged in educational work, their influence will be exerted to promote loyalty to the Government of Cyprus in the minds of their pupils and to make them good citizens of the British Empire:

Now, therefore, in exercise of the powers vested in him by section 8 of the Missionary, Educational and Medical (Alien Regulation) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to grant to the persons whose names appear in the Schedule hereto a permit respectively to commence or carry on the work set down after their respective names.

THE STREETS AND BUILDINGS REGULATION LAW.

CAP. 165 AND LAWS 10 OF 1950, 44 OF 1954, 18 OF 1955 AND 12 OF 1957.

NOTICE UNDER SECTION 14 (1).

In exercise of the powers vested in me by section 14 (1) of the Streets and Buildings Regulation Law, I, the Commissioner of Nicosia, as the appropriate authority in respect of the villages of Orta Keuy, Trakhonas, Omorphita, Mandres, Mia Milea, Eylenja, Engomi, Yerolakkos and Geunyeli and as Chairman of the Improvement Boards of Beuyuk Kaimakli, Palouriotissa, Strovolos and Ayios Dhometios, the appropriate authority under section 3 (2) (b) of the aforesaid Law, hereby with the approval of the Governor, revoke the notice published under Notification No. 700 in Supplement No. 3 to the *Gazette* of the 10th November, 1955, in so far as it affects the Improvement Area of Strovolos.

2. Notification No. 700 published in Supplement No. 3 to the *Gazette* of the 10th November, 1955, is hereby amended accordingly.
