ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 27th April, 1956, and published in Supplement No. 3 to the *Gazette* of the 3rd May, 1956, under Notification No. 363 (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Lapithos (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;
