THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

REVOCATION OF ORDER MADE UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor hereby revokes the Order made under Defence Regulation 64 and published under Notification No. 14 in Supplement No. 3 to the *Gazette* of the 3rd January 1957 (as extended by Notifications Nos. 579 and 1051 in Supplement No. 3 to the *Gazettes* of the 6th June, 1957 and 28th November, 1957, respectively) without prejudice to anything done or left undone thereunder.

THE PENSIONS LAW.

CAP. 288 AND LAWS 4 OF 1952, 1 OF 1955 AND 29 OF 1956.

REGULATIONS MADE UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Pensions Law, His Excellency the Governor, with the advice of the Executive Council and with the sanction of the Secretary of State, has been pleased to make the following regulations :—

1. These Regulations may be cited as the Pensions (Amendment) Regulations, 1958, and shall be read as one with the Pensions Regulations (hereinafter referred to as "the principal Regulations") as from time to time amended.

2.—(1) The principal Regulations are hereby amended by substituting—

- (a) for the words "the service of Cyprus" and "service in Cyprus", wherever they occur, the words "service under the Government of Cyprus";
- (b) for the words "wholly in Cyprus" in Regulations 3, 9 and 10, the words "wholly under the Government of Cyprus";
- (c) for the words "a pensionable office in Cyprus" in Regulation 4 the words "a pensionable office under the Government of Cyprus";

- (d) for the words "a pensionable office or offices in Cyprus" in Regulation 6, the words "a pensionable office or pensionable offices under the Government of Cyprus";
- (e) for the words "if the whole of her public service had been in Cyprus" in Regulation 13, the words "if the whole of her public service had been under the Government of Cyprus".
- (2) This Regulation shall come into force on the day on which the Pensions (Amendment) Law, 1958, comes into force.

3. The Appendix to the principal Regulations is hereby amended as follows :—

- (a) by the insertion therein, in its proper position in alphabetical order, of the word "Ghana";
- (b) by the substitution for the words "Crown Agents for the Colonies" of the words "Crown Agents for Oversea Governments and Administrations";
- (c) by the substitution for the words "Employing Authorities under the Colonial Superannuation Scheme" (as set out in Regulation 13 (a) of the Pensions (Amendment) Regulations, 1952) of the words "Employing Authorities under the Oversea Superannuation Scheme".

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
 REGULATIONS, 1955 TO (No. 5) 1957.**

ORDER UNDER EMERGENCY REGULATION 39A.

Whereas I am satisfied that the house and outbuildings of Costas Dracos in the village of Omodhos has been used by terrorists :

Now, therefore, I, R. St. J. O. Wayne, Commissioner of Troodos, with the approval of the Governor hereby order the forfeiture of this house. I further direct with the approval of the Governor that such buildings and other structures and their contents as may be necessary for the safe destruction of explosives concealed there shall be demolished.
