Publication of results.

- 12.—(1) The results of each examination with names of those who have passed shall be published in Force Weekly Orders. The result of each examination shall be recorded in the personal record of each candidate.
- (2) After every examination a candidate who failed to pass that examination shall be informed of the subject or subjects in which he failed to pass.

Gazetted Officers categories.

- 13. For examination purposes, Gazetted Officers, shall be divided into two categories viz.:—
 - (a) Officers of the permanent establishment on probation.
 - (b) Officers on contract.

Gazetted Officers.

14. Gazetted Officers of the categories mentioned in Regulation 13 may be required by the terms of their appointment to pass the following examinations within a specified time limit:—

Language Examinations.

(a) Language Examinations: As laid down from time to time in the Cyprus General Orders.

Examination in Colonial Regulations and G.O. 's.

(b) Examination in Colonial Regulations and General Orders: As laid down from time to time in the Cyprus General Orders.

Police subjects examination.

(c) Examination in Police Subjects: As laid down in paragraph (b) of regulation 7 of these Regulations.

Examination prerequisite for renewal of contract, etc.

15. It shall be a prerequisite for renewal of contract, confirmation of appointment or transfer to the permanent and pensionable establishment that a Gazetted Officer shall pass all the examinations required of him by the terms of his appointment.

Failure to pass examinations.

- 16. Failure to pass the examinations within the specified period may entail for both classes of Gazetted Officers:—
 - (a) deferment of increment;
 - (b) release from the Force;
 - (c) where the promotion was from within the Force, reduction to the rank held by the Gazetted Officer immediately before promotion.

THE POLICE LAW, 1958.

REGULATIONS MADE UNDER SECTION 10.

In exercise of the powers vested in me by section 10 of the Police Law, 1958, I, the Chief Constable, with the approval of the Governor, do hereby make the following Regulations:—

Short title and application.

1.—(1) These Regulations may be cited as the Police (United Kingdom Unit) Regulations, 1958, and shall apply to all police officers domiciled in the United Kingdom who are seconded to the Cyprus Police Force from a United Kingdom Force and have the right of reinstatement to such United Kingdom

Force (and all such officers are hereinafter in these Regulations referred to as "members of the United Kingdom Unit").

- (2) These Regulations shall come into force on the first day of May, 1958.
 - 2. Subject to the provisions of these Regulations any regulations made Application under the provisions of section 10 of the Police Law, 1958, shall have applica- of regulation to all members of the United Kingdom Unit.

tions made under the Police Law.

3. Whenever it appears that any member of the Unit may have committed Reporting of any disciplinary offence against the Police (Discipline) Regulations, 1958, or offences against Colonial Regulations, the matter shall be reported to the most senior officer of the United Kingdom Unit other than the Chief Constable or Deputy Chief Constable (hereinafter referred to as "the senior United Kingdom Officer").

4.—(1) Upon receipt of any report under regulation 3 of these Regulations, Investithe senior United Kingdom officer as in that regulation defined shall investigate the matter with a view to ascertaining whether or not there is a prima facie case to support a charge of committing a disciplinary offence.

(2) The senior United Kingdom officer may appoint a suitable member of the United Kingdom Unit, acting under his direction, to carry out an investigation as aforesaid.

5. The senior United Kingdom officer shall as soon as possible inform Personal the member of the United Kingdom Unit, against whom the allegation is explanation. made in writing, of the report or allegation, and give him a written notice informing him that he is not obliged to say anything concerning the matter, but that he may, if he so desires, make a written or oral statement to the investigating officer, or to the Chief Constable.

6. If, as a result of the investigation carried out, the senior United King- Offences by dom officer is of the opinion that in the case of an officer not of gazetted rank non-gazetted a charge should be preferred, he shall prepare the charge and arrange for the ranks. case to be enquired into, and tried by the Chief Constable or the Deputy Chief Constable.

7.—(1) At the trial of any member of the United Kingdom Unit by the Procedure at Chief Constable or his Deputy the senior United Kingdom officer may either hearing. act as presenting officer himself or he may appoint a member of the United Kingdom Unit to act as such. The accused police officer shall be entitled to have a serving police officer to assist him with his defence.

- (2) The trial of any member of the Unit by the Chief Constable or his Deputy shall be conducted, as nearly as may be, in accordance with the regulations in force for the time being in the United Kingdom for the trial of police officers for disciplinary offences.
- 8.—(1) The Chief Constable or his Deputy, as the case may be, shall have Punishments. power to impose respectively the punishments set out for inspectors or nongazetted officers and constables in regulation 18 (1) of the Police (Discipline) Regulations, 1958.

(2) The decision of the Chief Constable or his Deputy to impose any punishment in any case tried by him under these Regulations shall be subject to appeal to the Governor within seven days from the date of the communication of the decision of the Chief Constable or his Deputy to the accused police officer and the decision of the Governor shall be final:

Provided that where the punishment imposed is one of dismissal, requirement to resign or reduction in rate of pay, such punishment shall not be carried out without the confirmation thereof by the Governor, and the police officer concerned shall have the right to appeal to the Secretary of State against the imposition of such punishment within fourteen days of the communication to him of the Governor's confirmation of the punishment.

Offences by gazetted officers.

9. If as a result of investigation carried out, the senior United Kingdom officer is of opinion that a member of the gazetted ranks has been guilty of misconduct which merits disciplinary proceedings under Colonial Regulations he shall report the circumstances to the Chief Constable.

10. The Police (United Kingdom Unit) Regulations, 1955, and the Police (United Kingdom Unit) (Amendment) Regulations, 1956, are hereby revoked without prejudice to anything done or left undone thereunder.

THE POLICE LAW, 1958.

RULES MADE UNDER SECTION 52(4).

In exercise of the powers vested in him by section 52(4) of the Police Law, 1958, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following rules:

I. These Rules may be cited as the Cyprus Senior Police Officers' Association Rules, 1958, and shall come into force on the first day of May, 1958.

2. In these Rules, unless the context otherwise requires —
"Assistant Superintendent of Police" includes a temporary Assistant Superintendent of Police but does not include an Acting Assistant Superintendent of Police.

3. There is hereby established an association to be called the Cyprus Senior Police Officers' Association (in these rules referred to as "the Association '').

4. Police Officers for the time being of the ranks of Chief Superintendent, Superintendent and Assistant Superintendent shall be members of the Association:

Provided that this rule shall not apply to a police officer who, within one month of the making of these rules or within one month of his qualifying to become a member of the Association, gives notice in writing to the Secretary of the Association of his intention not to become a member of the Association:

Provided further that any member of the Association may resign therefrom by notifying in writing the Secretary of the Association of his desire to do so:

Provided further that a police officer who has resigned from the Association may, if he is eligible, at any time rejoin the Association by notifying the Secretary of the Association of his desire to do so.

5. The affairs of the Association shall be managed by a Committee. 6.—(a) The Committee shall consist of an elected representative from each of the following Divisions and Units:

Headquarters, Nicosia, Limassol, Famagusta, Larnaca, Paphos, Lefka, Kyrenia, Troodos, Fire Service Headquarters, Mobile Reserve Headquarters, Port and Marine Headquarters.

(b) Members of the specialist departments (Mobile Reserve, Fire Service, Criminal Investigation Department, Special Branch, etc.) will be eligible for election in the Division to which they are attached.

(c) The election of representatives will be by secret ballot, from nominated candidates who have been properly proposed and seconded.
